B. Old Business

1. Council approved the alcoholic beverage license name change request from Kimberly Adams dba Moose Lodge 1930 located at 206 Harmon Road .

5. Council heard a request from Joseph Bynes regarding the use of the old recycling center for a pilot work program for veterans. Mr. Bynes stated that they would lease the building and maintain all equipment at no cost to the city. Councilperson Parker made a motion to allow Mr. Bynes to lease the building. Council approved Mr. Bynes request pending the approval of a written proposal from Mr. Bynes to the city.
