



City Council Meeting

November 01, 2021

The regular meeting of the Mayor and City Council was held Monday, November 01, 2021 at 6:00 P.M. at the Swainsboro City Hall.

Minutes were considered from the October 25, 2021 called meeting and motion was made to accept minutes.

B. New Business

1. Fire Chief Mike Strobridge presented the council a check from the ISO - Insurance Safety Commission in the amount of \$600,492.70. Chief Strobridge spoke about how the training and other requirements affect the amount the city receives each year.

2. Shane Cox with Clearwater Solutions presented three quotes for repairs at Well #9, Well #4 and Lift Station #15. Council considered these request and approved all three requests.

3. Stanley Wimberly from Men Reaching Men Outreach spoke about the upcoming Prayer Vigil at the Swainsboro Boneyard Pavilion on November 20, 2021 at 3 P.M.

4. Councilperson Faulkner presented a request from Al Huston to rename the Gumlog Park to Gerald R. Phillips Community Park. Motion was made by Councilperson Faulkner to rename the park and purchase a sign reflecting the name change.

5. Greg Bennett submitted a request for water and sewer services for a new subdivision on Fairground Road. Mr. Bennett stated that it would cost the city approximately \$76,000 to run sewer and \$20,000 to run water to this new subdivision. Mr. Bennett stated that the cost of this project would be offset by the increased tax and water revenue.

6. Council heard the second reading for an application for a name change on an alcoholic license (for advertisement only) from Clint Derek Crews dba Walgreens located at 390 South Main Street.

7. Motion was made by Councilperson Parker to approved the adoption of the Language Access Plan.

8. Council spoke about the American Rescue Act. Councilperson Faulkner requested that we ask Mr. Willie Burns come speak with the council regarding the American Rescue Act.

9. Mayor Schwabe gave the council an update on the Gym project and the Theater project.

1.Mayor Schwabe stated we will not ratify the 2022 millage rated due to an error on the 5 year history ad. The corrections will be made an re-advertised. Motion was made by Councilperson Sconyers to poll the council by email on November 4, 2021 to ratify the millage rate.
